PRESIDENT'S REPORT MELANIE LANTZ



A year ago, I opened with an account of how 2020 changed us, changed the world we live in, and how we as a Foundation became better and stronger for it. As I reflect back on 2021, we are still living with the pandemic, but feel we've truly transformed. We are still governed largely by virtual technology to keep our social, career, and even supply chain networks alive. My hope moving forward is we can revitalize these networks again in-person as we move into 2022.

2021 presented a new set of challenges for the classroom. Resurgent waves of COVID-19 kept in-class student participation limited for many schools. For those who were able to return, pandemic restrictions regulated the ability to move about, interact, learn, and play. The incredible dedication of teachers, education, and industry support staff around the province to the health and safety of BC's students was evident as more children returned to class while COVID-19 numbers in classrooms were kept largely in check.

2021 was also a year of some great successes. We kicked off the year with our first online silent auction at the virtual BC Agriculture Council (BCAC) Gala/Pacific Agriculture Show in January. Thank you so much to all of you who participated. We raised a record-breaking \$13,000 over the course of the Agriculture Show. We truly appreciate our ongoing partnership with BCAC. The proceeds of this annual auction enable us to further assist the agriculture programs we can offer in schools.

I would also like to recognize the work of our Executive Director Pat Tonn and the amazing Staff here at BCAITC for another banner year. They were able to maintain our school programs and support program growth as things returned to capacity over the school year. BCAITC also engaged in a new public outreach

through a partnership with We Heart Local BC. It was facilitated through virtual Cook-Alongs with Chef Randle which made for a number of fun evenings to further distract us from the confines of the pandemic.

Our Board continued to operate virtually via Zoom, but we look forward to the day when we can convene in-person again. We said goodbye to one of our long-time Board members, Sydney Massey who has been a true advocate of the BCAITC and an actively engaged for several years. Her presence will be missed. I am happy to report that on the flip side of Sydney's departure, we welcomed Carmen Gorlick to the Board. Carmen is a registered Dietician and will represent the Health Sector for the first of her two-year term.

Sadly, 2021 ended in a downturn. The impacts of extensive flooding on the Sumas Prairie in the Fraser Valley were devastating and felt in every corner of our province. We lost our beloved Pencil Patch teaching garden but will commit to rebuilding. I would also like to acknowledge the Mutz family of Berry Haven Farm who graciously offered us use of their packing facilities. Because of their generosity, we were able to package and send out the balance of our fall program materials to schools across the province.

In conclusion, I want to thank all of you who work so tirelessly to advocate for Agriculture. It takes the support and dedication of so many to make BCAITC great. 2021 has been a true test of our commitment to this industry and we wish to acknowledge all of you who have helped us on this journey to promote Agriculture and food literacy to thousands of students across the province.

New beef resources kits for the classroom with BC Cattlemen's Association, a Planting Intergenerational Promises tulip growing resources with the Dutch Liberation Canadian Society, and a new Indigenous Common Ground Strawberry Project this year. We expanded ag-tech career resources through Agrilyze, an agriculture reading challenge with the Entomological Society of BC, tours in our Pencil Patch Garden with the Mainland Milk Producers and partnership virtual career programs with AITC-Canada.

Cook-alongs with Chef Trevor Randle kept

everyone entertained and cooking with BC products when staying close to home this year. Thanks to all commodity groups and We Heart Local BC, who joined us in presenting BC Farmers and food at their finest! BC Landscape and Nursery Association and Windset Farms supported our summer get growing contests too! The Field to Fork Challenge was a popular program once again in partnership with 4-H BC and Youth Development programs in the Ministry of Agriculture, youth of all ages prepared BC products, cooking and learning together with Chef Randle and BC Farmers.

The floods of November in Abbotsford caused havoc with our Pencil Patch learning garden; we will have to rebuild on that location. We are excited about a new partnership we are building with Stable Harvest Farm in Langley. Look for us doing Ag Adventures educational farm tours in the new year at that location while we rebuild in Abbotsford.

VIRTUAL LEARNING

Over 550 resources and recipes are available on www.bcaitc.ca to help K-12 students learn about agriculture and food! Dozens of new lessons, activities, videos, and recipes were developed in 2021 to accommodate new learning environments. Teachers, home educators, and students are able to download our resources anytime/anywhere for flexible learning.



NEW RESOURCES

More than two dozen forward-thinking K-12 resources were developed in 2021. Highlights include:

- **Spotlight Series:** An extensive array of new spotlights introduced farm-to-table education on duck, pork, blueberries, chicken, honey, and hazelnuts to Culinary Arts and Food Studies students. The multifaceted toolkits include educational farm videos, lesson plans, activities, recipes, and Grow BC resources.
- **Beef Resources:** New unit plans at three education levels were introduced to explore topics like production, lifecycles, sustainability, land management, and careers with curriculum connections to Science, English Language Arts, Social Studies, Careers, Food Studies, and Culinary Arts.
- **Planting Intergenerational Promises:** A new activity kit was developed for the Planting a Promise program to provide educational opportunities for students to build relationships with seniors through the growing and sharing of flowers. It includes links to Art, English Language Arts, and Social Studies.
- **Canadian Agriculture Literacy Month Resources:** Invent a Bug Lesson Plan, an elementary lesson with links to Science, was developed to tie in with the month's feature book, 'A Bug Girl'.
- **Agrilyze Career Profiles:** A new partnership with Agrilyze introduced 5 new leading-edge ag-tech career resources to our classroom communities.

BUILDING HEALTHY MINDS AND BODIES

BC SCHOOL FRUIT AND VEGETABLE NUTRITIONAL PROGRAM

With the help of over 4,500 volunteers and dedicated industry partners, the BC School Fruit and Vegetable Nutritional Program provides BC grown fruit and vegetable snacks to classrooms 12 times a year. This program gives students the opportunity to sample BC produce such as apples, plums, pears, tomatoes, mini cucumbers and peppers - and even kiwifruit! The popular program is delivered to over 90% of public and First Nations schools in British Columbia, reaching over half a million students annually.

Educators can use the program's 30 Fresh Stories lessons to help students make the connections between farming and the food they eat.



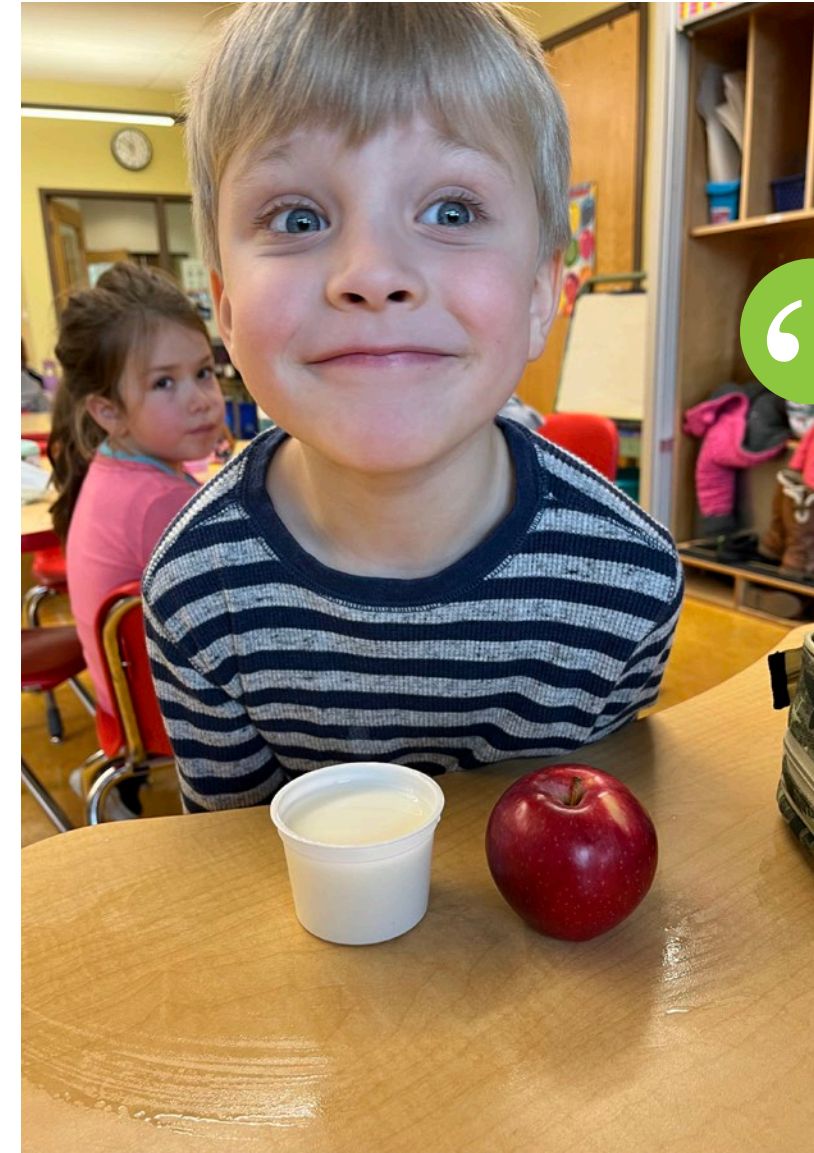

SPUDS IN TUBS

Spuds in Tubs provides an amazing hands-on gardening experiences for K-12 students! Over a few months, students plant seed potatoes, tend to and observe the plants, and then harvest hundreds of potatoes to eat!

HARVEST BIN PROJECT

The Harvest Bin Project provides schools with bins as raised beds and seed money for establishing their own working mini-farms and gardens. Students enjoy the fruits of their labour with fresh, locally grown food!

Planting, maintaining, and harvesting the gardens with the 3-year program offers hands-on learning about how to operate a farm on a small scale. From caring for the soil to learning about plant life cycles and pollinators, this program models the principles of sustainable agriculture.

SUMMER INSTITUTE

Cultivating learning! The BCAITC and the UBC Faculty of Education's Summer Institute course (held annually each July) provides teachers with tools and resources to help them integrate concepts related to food, the agriculture industry, and environmental sustainability into their classrooms.

The Summer Institute, held in-person from 1999 to 2019, was again delivered virtually in 2021 due to the COVID-19 pandemic. The 5-day online course provided participants from all over BC the opportunity to learn from the comfort of their own homes. Course highlights included cook-alongs with Chef Trevor Randle, presentations from BC agri-food industry representatives, farm video tours, projects, and discussions.

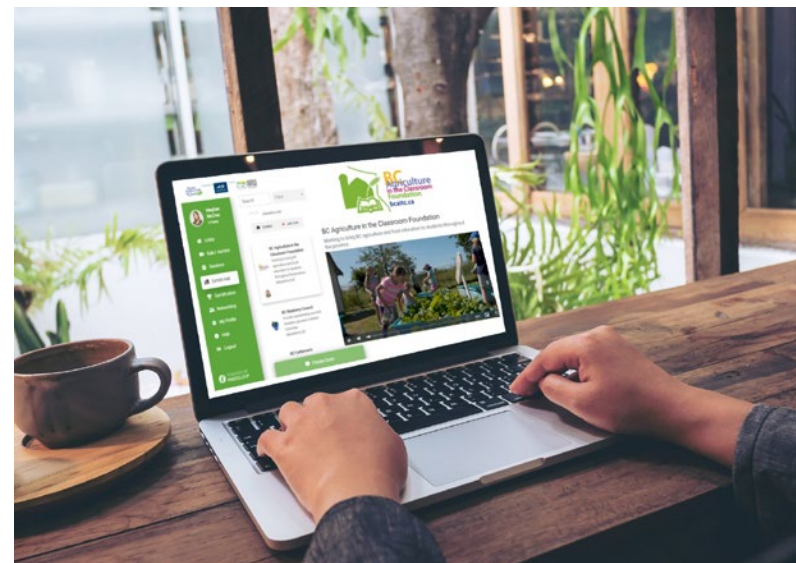

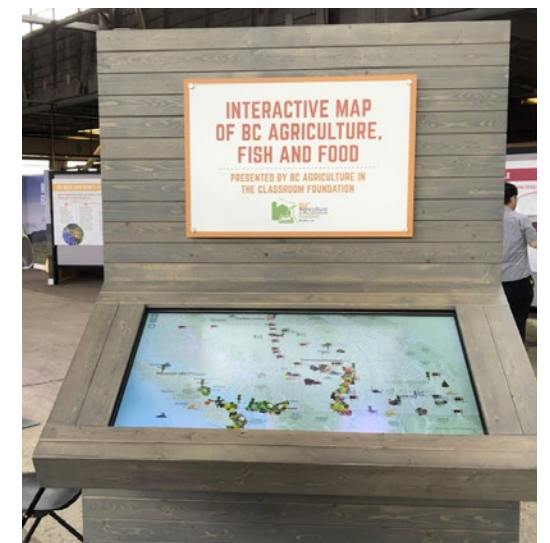

January to June 2021

The start of this year was unlike any due to the COVID-19 pandemic!

During the first part of 2021, I assisted with organizing the virtual visitor booth for the Tapestry Conference. Additionally, I presented a workshop at the BCTF New Teachers Conference about building a TOC Toolkit of agricultural resources. At this conference, attendees participated in an engaging virtual agriculture commodity Scavenger Hunt using the Grow BC map, as well as built an electronic binder of Teacher Resources using curriculum-aligned resources from our website.

March 2021 celebrated Canadian Agricultural Literacy Month (CALM) and launched several new initiatives. We rolled-out two online student Ag-Reading challenges in which students logged their reading time in our web portal. Students earned virtual badges and prizes! "The Bug Girl" was the feature book for CALM with accompanying lesson plans aligned with the BC curriculum. The results from the Ag-Reading Challenges were incredible - 773 participants in 82 schools, reading 840,410 minutes, completing 2,779 book reviews, and earning 6,158 virtual online badges throughout March!

During the months of March and April, I also coordinated 7 farmer visits, where a BC farmer virtually visited a classroom to discuss their commodities and answer student questions. Additionally, I presented a workshop for a Home Economics teachers on 'Virtual Ready Ag-Resources that I had built for remote learning, such as a Kahoot Game, a Jeopardy game, and a Quizlet on important agricultural commodities in BC. The Home-Economics Teacher Collaboration Group had participants from across the Fraser Valley, who found the electronic resources both useful and timely.

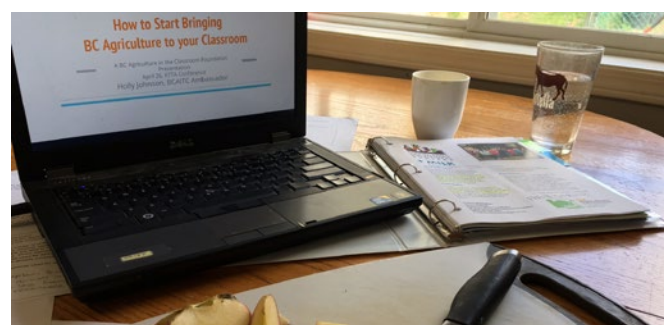
Another initiative that I undertook in the spring was with Agrilyze, an analytics platform for BC's agriculture industry, to promote a 10-week blog series on emerging ag-tech sector

careers. I created a video launching this series and assisted Agrilyze in developing profiles promoting careers in agricultural technology for K-12 students.

My last few months at BCAITC I began the development of a new growing program called "Common Ground: The Strawberry Project". It is designed to nurture relationships among students across the province developing a greater understanding of Indigenous ways through growing native plant species.

The project sets goals for students to engage in relations of peace and understanding through a common activity of planting, growing, harvesting and eating all well exchanging observations and learning between First Nations and public school classes. Teachers enrolled in the program will receive a classroom kit in January 2022 including strawberry seedlings, a teacher's guide and everything to grow strawberries.

As my final weeks as Education Specialist come to a close, I would like to thank the team at BCAITC and educators throughout the province who promote the importance of agriculture in their classrooms. Students deserve to know where their food comes from, how to grow their own food, and why farms and agriculture play such an important role in our communities and society.

A teaching colleague once asked me if I would

ever like to do another job besides classroom teaching. I said no. In September of 2021, I started a new job working three days a week as BCAITC's Education Specialist! It has been different from classroom teaching but an exciting opportunity to combine my passions for teaching, farming, and food.

One of the first projects I had the pleasure of working on at BCAITC was the Field to Fork Challenge in partnership with 4-H BC. One activity I created was a 'Choose your Own Adventure' for the hazelnut industry which highlighted how the industry has changed over time. The Spotlight Series for honey, chicken, and blueberries, were also finalized and shared.

In October, I was able to deliver a virtual workshop about our Fresh Stories resources. I made pickled plums and drew tomato plants with intermediate teachers from across BC. I also participated in some initial planning for our Ag Adventures program at the new Stable Harvest Farm location.

During Canada Career Month, I had the opportunity to present about Biology Careers in Agriculture to students at Trinity Western University. I also attended the Career Education Society Conference to network with careers teachers and learn about creating agriculture career experiences for students of all ages.

I kicked off the month of December presenting to future Home Economics teachers at UBC, and was able to share with them our many recipes and resources. December was also full of creating, and editing content for the new signs at Stable Harvest Farm.

I am grateful for the opportunities to share BC's food story with BC students and teachers this year, and am looking forward to the new projects 2022 holds.

Basis for Qualified Conclusion

In common with many not-for-profit organizations, British Columbia Agriculture in the Classroom Foundation derives revenue from fundraising activities, the completeness of which is not susceptible to me obtaining evidence I considered necessary for the purpose of the review. Accordingly, the evidence obtained of these revenues was limited to the amounts recorded in the records of British Columbia Agriculture in the Classroom Foundation. Therefore, I was unable to determine whether any adjustments might have been found necessary with respect to fundraising revenue, excess of revenue over expenses, and cash flows from operations for the years ended December 31, 2021 and 2020, current assets as at December 31, 2021 and 2020 and net assets as at January 1 and December 31 for both the 2021 and 2020 year ends. My conclusion on the financial statements as at and for the year ended December 31, 2020 was modified accordingly because of the possible effects of this limitation in scope.

Qualified Conclusion

Based on my review, except for the possible effects of the matter described in the Basis for Qualified Conclusion, nothing has come to my attention that causes me to believe that the financial statements do not present fairly, in all material respects, the financial position of British Columbia Agriculture in the Classroom Foundation as at December 31, 2021, and results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.





1. PURPOSES OF THE ORGANIZATION

British Columbia Agriculture in the Classroom Foundation is a non-profit organization and was incorporated under the *Society Act* of British Columbia on August 9, 1999. The foundation is a charity registered under section 149(1)(i) of the *Income Tax Act* and is therefore not subject to taxation.

The purposes of the foundation are:

- to promote an awareness and understanding of sustainable agriculture and food systems in B.C. Schools;
- to enable students to make informed decisions about food choices, food safety, the importance of our own supply of food and other agriculture products as well as the protection of B.C.'s agriculture resources;
- to foster awareness of careers to be found in agriculture and food systems;
- to attract funding for the research, development and implementation of programs to meet the above stated purposes of the society;
- to provide classroom ready resource material and activities on the agri-food system which can be integrated into the existing school curriculum;
- to provide in-service professional development on the agri-food system for British Columbia teachers; and
- to establish a clearing house of agri-food system resources for classroom teachers.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accounting policies of the foundation are in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO). Outlined below are those policies considered particularly significant.

The financial statements have, in management's opinion, been properly prepared within reasonable limits of materiality and within the framework of the accounting policies summarized below:

(a) FUND ACCOUNTING

The Foundation follows the restricted fund method of accounting for contributions.

The General Fund accounts for the organization's program delivery and administrative activities. This program reports unrestricted resources and restricted operating grants.

The Capital Asset Fund reports the assets, liabilities, revenues and expenses related to the Foundation's Capital Assets.

(b) INVENTORY

Inventory, which is comprised of publication materials held for distribution, is valued at the lower of cost or replacement cost.

(c) USE OF ESTIMATES

When preparing financial statements in accordance with ASNPO, the Foundation makes estimates and assumptions relating to:

- Reported amounts of revenues and expenses;
- Reported amounts of assets and liabilities; and
- Disclosure of contingent assets and liabilities.

Management's assumptions are based on a number of factors, including historical experience, current events and actions that the organization may undertake in the future, and other assumptions that I believe are reasonable under the circumstances. Actual results could differ from those estimates under different conditions and assumptions. Estimates were used when accounting for certain items, such as the useful lives of assets, impairment of long-lived assets and deferred operating grants.

Amortization is based on the estimated useful lives of property, plant and equipment. These estimates and assumptions are reviewed periodically and, as adjustments become necessary they are reported in the periods in which they became known.

(d) REVENUE RECOGNITION

Restricted contributions are recognized as revenue in the year when related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Unrestricted investment income is recognized as revenue when earned.

(e) CONTRIBUTED GOODS

Products having a fair market value \$98,229 (2020 - \$ 54,238) have been donated to the foundation for use in their programs by the following organizations: BC Cattlemen's Association, BC Chicken Marketing Board, BC Dairy Association, BC Egg, BC Fresh, BC Frozen Foods, BC Hot House, BC Pork, BC Raspberry Growers Association, BC Salmon Farmer's Association, BC Shellfish Growers Association, BC Strawberry Growers Association, BC Tree Fruits, BC Turkey Marketing Board, Sofina Foods, Creekside Hothouse, Fraser Valley Special Poultry, Highline Mushrooms, Ocean Spray, Silver Valley Farms, South Alder Farms, Windset Farms, W&A Farms, and Pacific Pet.

(f) FINANCIAL INSTRUMENTS

The Foundation uses risk management to monitor and manage its risk arising from financial instruments. These risks include credit risk, interest rate risk and market risk.

The Foundation does not use any derivative financial instruments to mitigate these risks.

Credit risk

Credit risks arise from two sources; cash and cash equivalents and accounts receivable. Cash and cash equivalents are deposited with reputable, major financial institutions to limit the credit risk exposure. The credit risk from parties not paying accounts receivable is not considered to be significant.

Interest rate risk

The Foundation is exposed to interest rate risk with respect to cash equivalents. Changes in interest rates can affect the fair value of investments and the cash flows related to interest income and expense.

Liquidity risk

Liquidity risk exposure is dependent on the receipt of funds from Provincial Government grants and other sources to enable the Foundation to pay its liabilities as they become due.

Market risk

In my opinion, the Foundation is not exposed to any significant market risk.

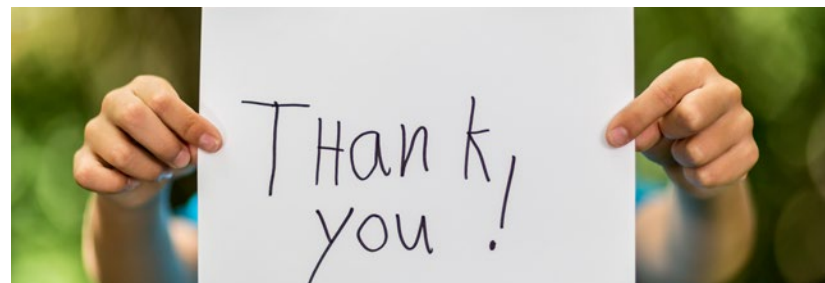
